### **4. APPLICATION / LIMITATION :**

4.1 - The fitting aboard to be the same as used for the test.

4.2 - This product is to be used as floor covering or primary deck covering only.

4.3 - Approved for use bonded with adhesive Glue UZIN KE 2000S with the application rate of not exceeding 350 g/m<sup>2</sup>. Use of any other alternative adhesive is subject to case by case approval, providing it has been approved as having low flame-spread properties.

### **5. PRODUCTION SURVEY REQUIREMENTS :**

5.1- This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type.
